Showing Proof On or Before Appearance Date

Mail-On or before your appearance date, you may mail in proof that your insurance or driver's license were valid at the time the ticket was issued and that offense may be dismissed. (A photocopy is acceptable)

If you received a ticket for expired vehicle registration, expired inspection sticker or expired driver's license and you renew within 20 days from the date of your ticket and mail proof of renewal to the courts on or before your appearance date on the citation, you may have your ticket dismissed with a \$20.00 fee. Inspection sticker cannot be expired for more than 60 days. *(does not apply to commercial vehicles)

IMPORTANT: SUBMIT TO THE COURT YOUR PLEA AND FINE BY THE APPEARANCE DATE ON CITATION. CASHIER CHECK OR MONEY ORDER (NO PERSONAL CHECKS ACCEPTED) PAYABLE TO FREESTONE COUNTY. SEND SELF ADDRESSED STAMPED ENVELOPE IF REQUESTING A RECEIPT.
