

REQUEST FOR DEFERRED DISPOSITION

(FAILURE TO REMIT THIS FORM ON OR BEFORE YOUR APPEARANCE DATE WILL RESULT IN INELIGIBILITY.)

Only eligible offenses listed below can request Deferred disposition through this request form. All other violations must be addressed when the Judge and/or Prosecutor for the state is present. Therefore, defendants requesting a Deferred disposition for other offenses must request a hearing through the reply form.

There may be other reasons you are not eligible for a Deferred disposition. Each case is unique and must be reviewed prior to granting a deferred disposition. If you send in paperwork and are not eligible, you will be notified of alternative options or be sent a summons to appear in Court.

Please indicate True OR False to the statements listed. If any are False, you are not eligible for the Deferred disposition and you must refer to the reply form.

T / F I hereby plead  NOLO CONTENDERE "no contest"  GUILTY to the charge.

T / F I am waiving my right to trial by jury, and my right to receive discovery or further discovery information pertaining to my case.

T / F I am 18 years of or older and I have a valid Texas driver's license or permit.

T / F I understand that if I am 25 years of age or younger at the time of the offense, by Texas law are automatically required to take a driver's safety course as a condition to the deferred disposition regardless of if it's been taken in the past 12 months.

T / F I am NOT currently under deferred disposition in any other court at the present time nor have I been under deferred disposition in the past 12 months.

T / F I understand that I am NOT ELIGIBLE for deferred disposition if I possess a commercial driver's license (CDL) or possessed a CDL at the time of the offense and the cited offense is related to "motor vehicle control".

T / F I understand that I am NOT ELIGIBLE for deferred disposition if the citation was issued in a construction zone with workers present.

T / F I understand that I am NOT ELIGIBLE for deferred disposition if the offense involves Passing a School Bus.

T / F I have ENCLOSED proof of a valid Texas driver's license or permit OR proof of active-duty military service if I possess a non-Texas driver's license. (a photocopy is acceptable – NO ORIGINALS PLEASE!)

T / F I understand that I will be responsible for paying the deferred disposition court costs and fees within 30 days of my approved request.

T / F I understand that the Court will review my request and notify me if I have been approved or denied for deferred disposition.

T / F I understand that if I successfully complete the terms of Deferred disposition in a timely manner, my case will be dismissed. If I do not successfully complete the terms of Deferred disposition Order, I will be sent a notice to appear in court to show cause why I did not complete the terms of the Order. If I fail to appear as required, it may result in a judgment of conviction.
